FCC POLLOCK, LA. UNIT TEAM ALTERNATE/COMPRESSED WORK SCHEDULE AGREEMENT

- 1. It is agreed that the Unit Team Staff at FCC Pollock, at the time of quarterly bidding, will have the option of bidding for 10 or 8 hour shifts in conjunction with bidding for late night coverage. All of the bidding will be chosen in the order of seniority in accordance with the Master Agreement. Option A on each Schedule will be 8 hour shifts, Options B and C will be 10 hour shifts. The Quarterly bidding for shifts and late nights for each Schedule will be decided by the roster committee in accordance with the Master Agreement.
- 2. Unit Team Staff at the FCI and USP will have the option of six quarterly schedules in which staff can bid for. FPC Unit Team staff will have the option of four quarterly schedules in which staff can bid for. Each quarterly schedule will have an A, B, and C option. Option A consists of five, 8 hour days. Option B and C consists of four 10 hour days. When the Roster Committee grants a staff member's selection, that schedule is eliminated. The hours of Option A will be 7:30 AM to 4:00 PM. The late night hours of option A will be 12:30 PM to 9:00 PM. Option B will be 6:00 AM to 4:30 PM, and Option C will be 7:00 AM to 5:30 PM. On Option A, weekend coverage will be given the option of working 6:00 AM to 2:30 PM or 7:30 AM to 4:00 PM. The late night hours for options B and C will be 10:30 AM to 9:00 PM. There will be no more than one late night with double coverage. The Unit Secretaries will have the Option of choosing between three schedules. Schedule A will be Monday thru Friday, 7:30 am to 4:00 pm. Schedule B and C will consist of four 10 hour days. On schedules B and C, Each Secretary will have the option of working Monday thru Thursday or Tuesday thru Friday. Normally, whichever schedule an employee is granted during the Roster Committee is the schedule they will remain on for the entire quarter. In the event a staff member requests to revert back to the 8 hour schedule they will remain on that schedule for the remainder of the quarter. Approval for the change will be in accordance with the Master Agreement.
- 3. For training in excess of one work day, the effected staff member will revert to the 7:30 AM to 4:00 PM Monday through Friday schedule, and only for the specific week of training.
